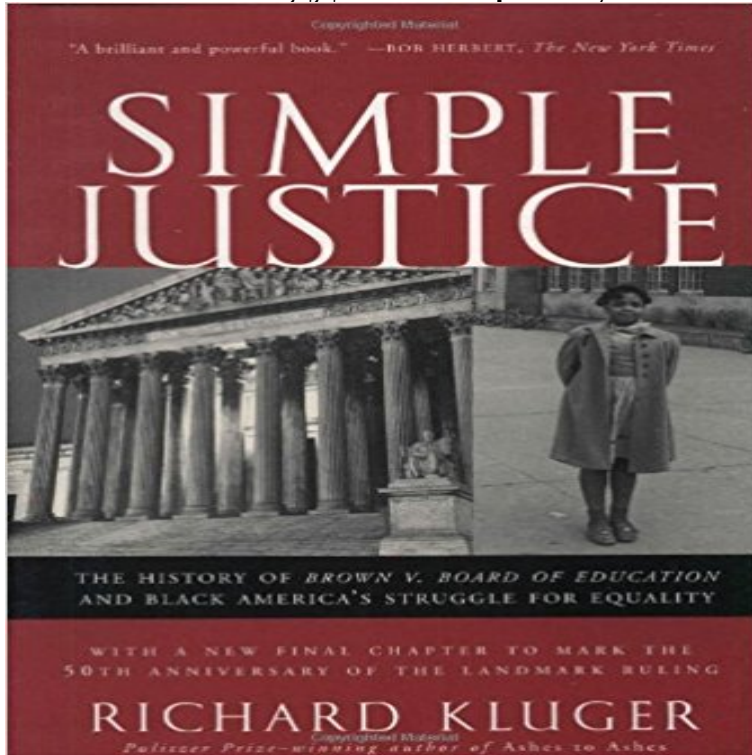


Simple Justice: The History of Brown v. Board of Education and Black Americas Struggle for Equality
