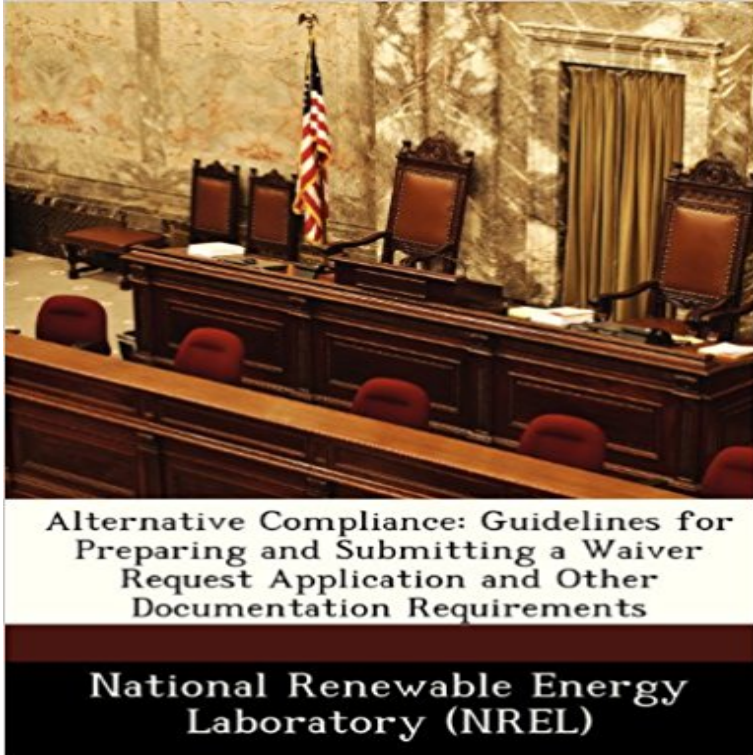


Alternative Compliance: Guidelines for Preparing and Submitting a Waiver Request Application and Other Documentation Requirements
