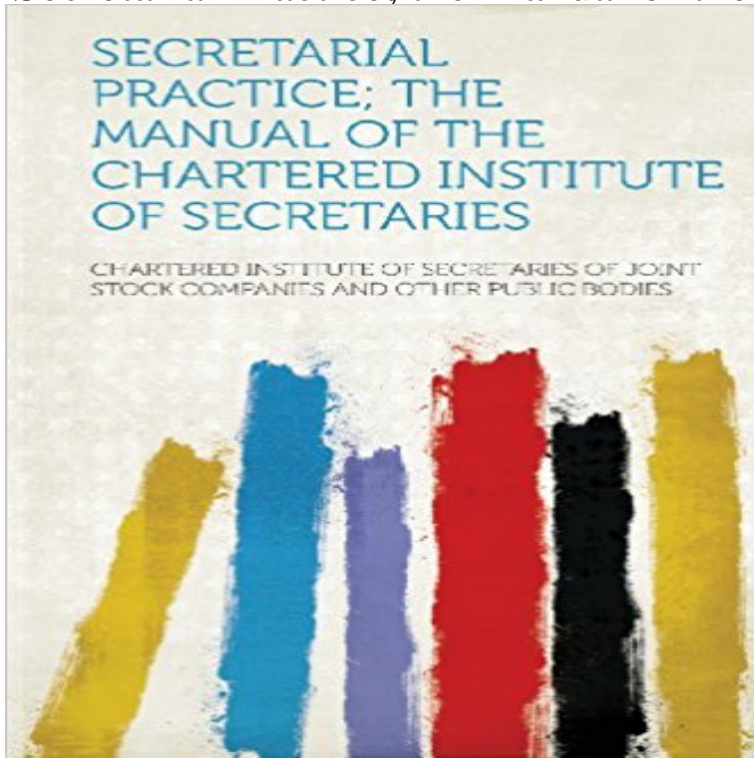


# Secretarial Practice; the Manual of the Chartered Institute of Secretaries
