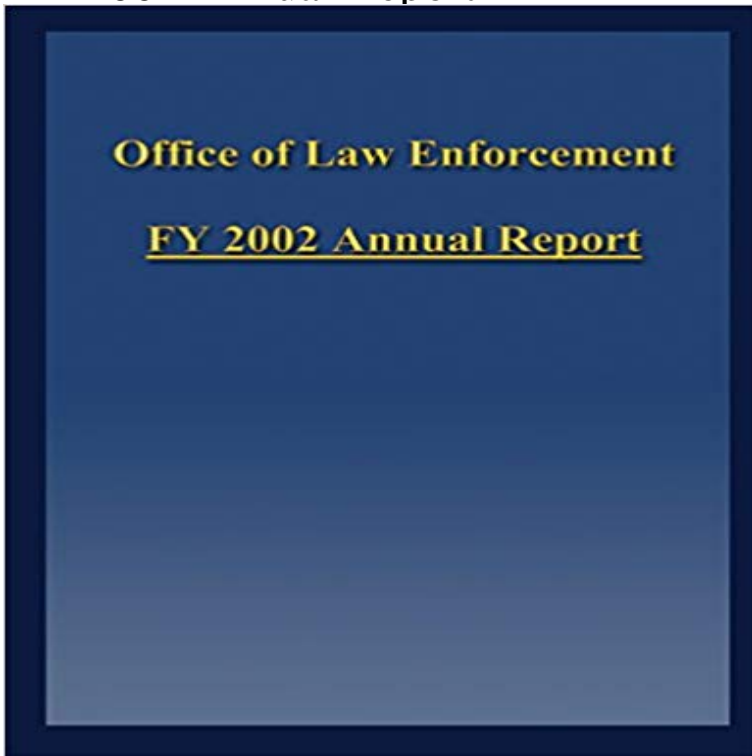


## FY 2002 Annual Report
