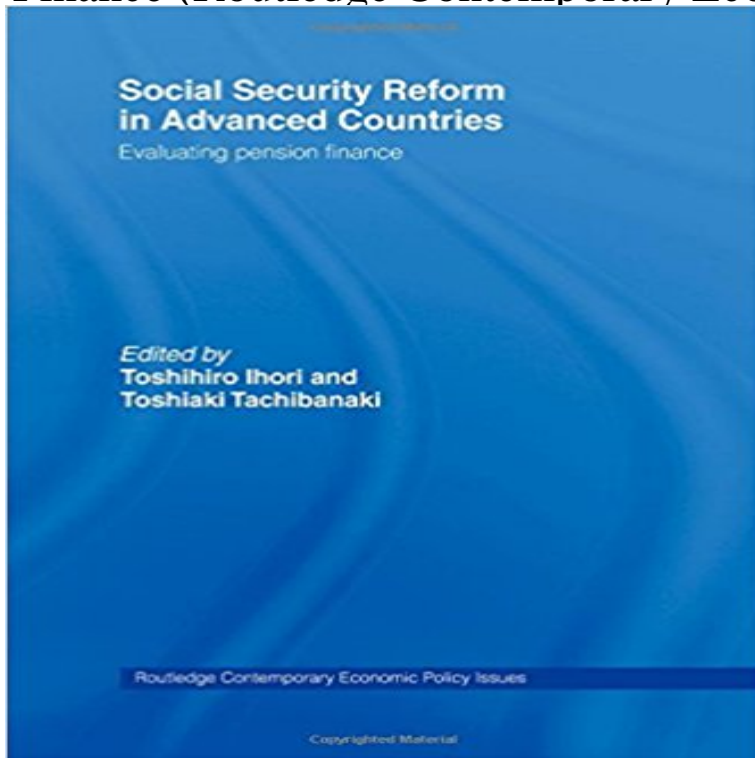


# Social Security Reform in Advanced Countries: Evaluating Pension Finance (Routledge Contemporary Economic Policy Issues)
