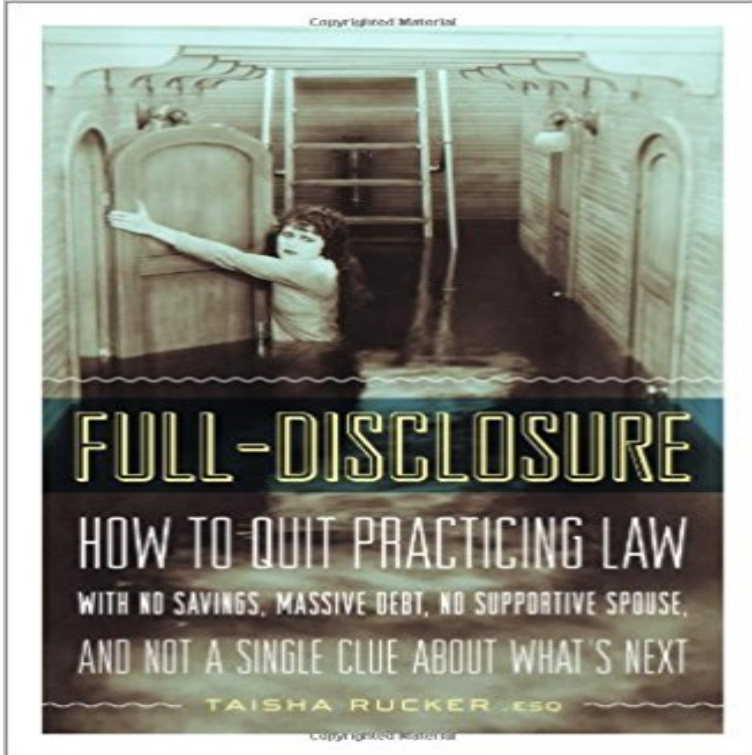

Careers outside the law for at least half of the lawyers may be a necessity more than just an option. There are life and career coaches, some of whom are former lawyers themselves, who assist lawyers in making this transition. But, for the most part, lawyers are on their own, trying to explain: why they no longer want to practice law; how theyre really willing to take a job that pays \$40,000 a year when they used to earning six figures; and trying to figure out how to make billing sessions with a life coach (mental health analyst) a transferable skill.
