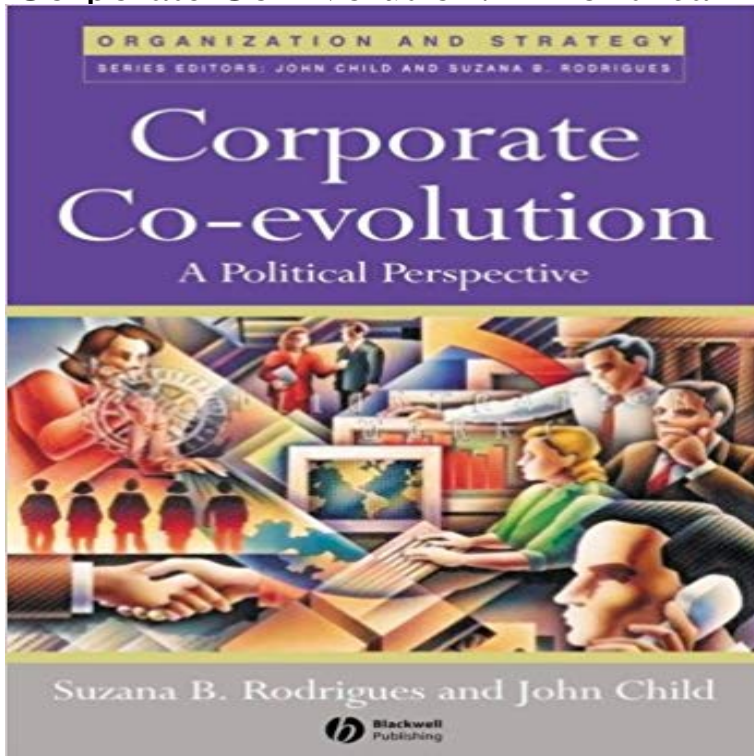


## Corporate Co-Evolution: A Political Perspective
