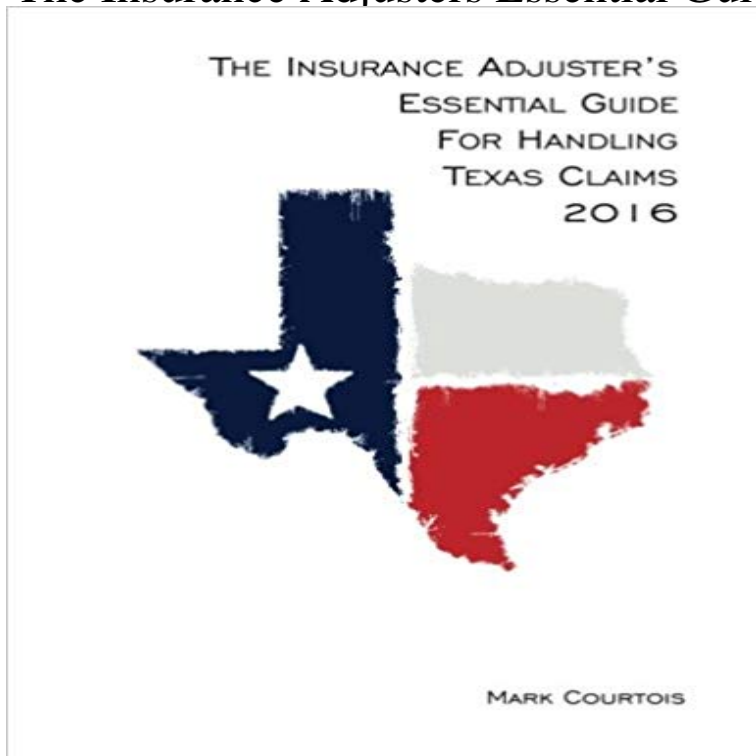


# The Insurance Adjusters Essential Guide for Handling Texas Claims
