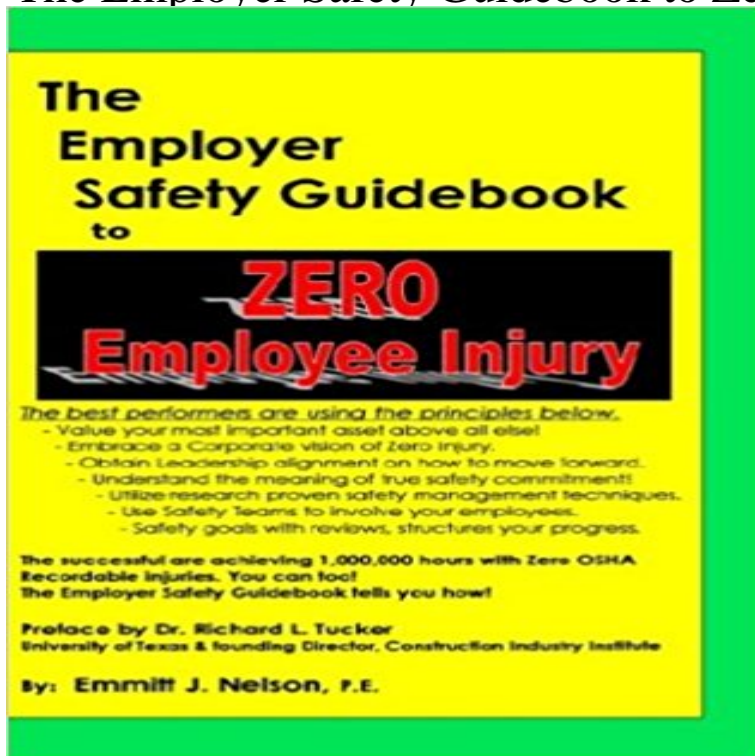


The Employer Safety Guidebook to Zero Employee Injury
