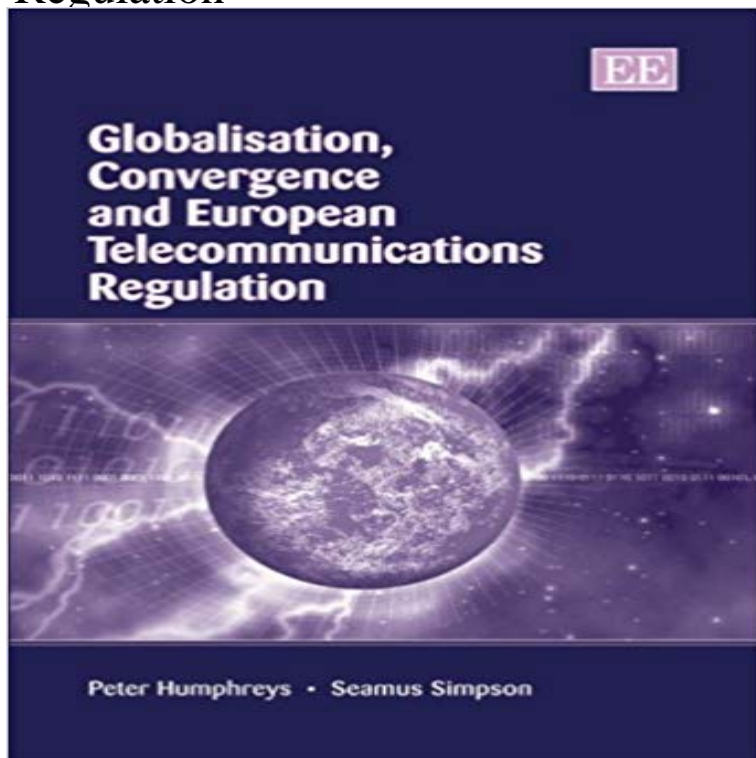


# Globalisation, Convergence And European Telecommunications Regulation
