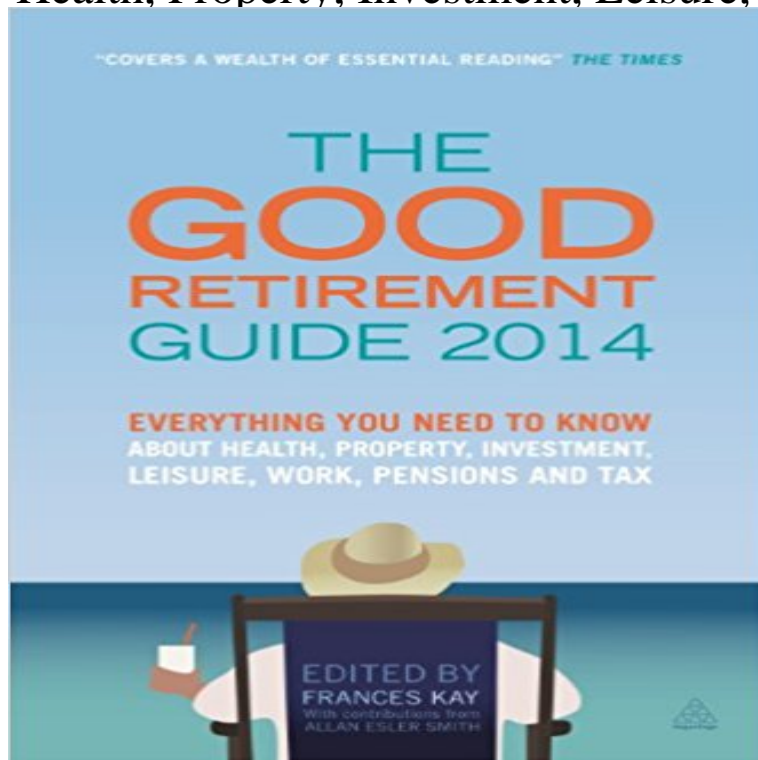


The Good Retirement Guide 2014: Everything You Need to Know About Health, Property, Investment, Leisure, Work, Pensions and Tax
