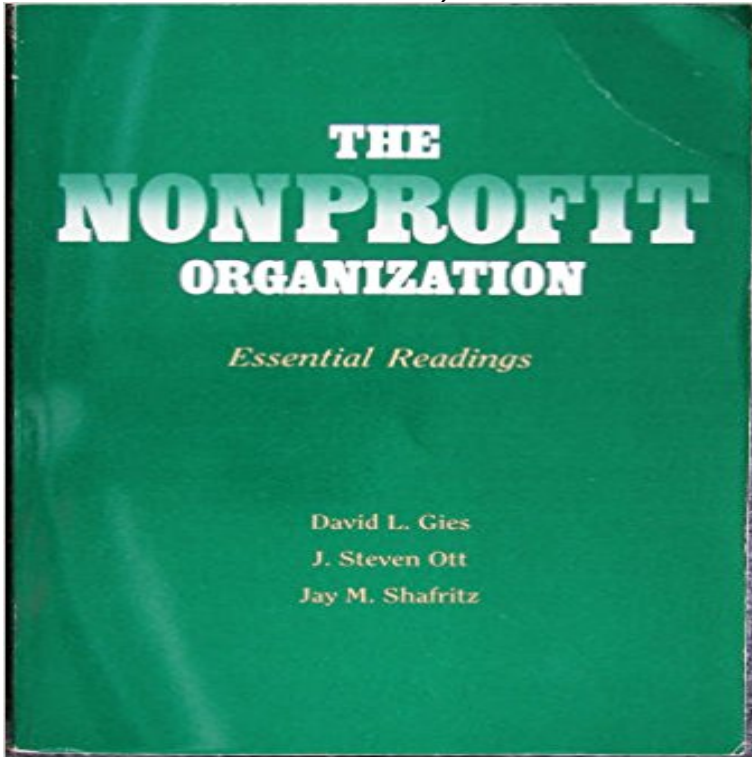


The Nonprofit Organization: Essential Readings (Brooks/Cole Series in Public Administration)
