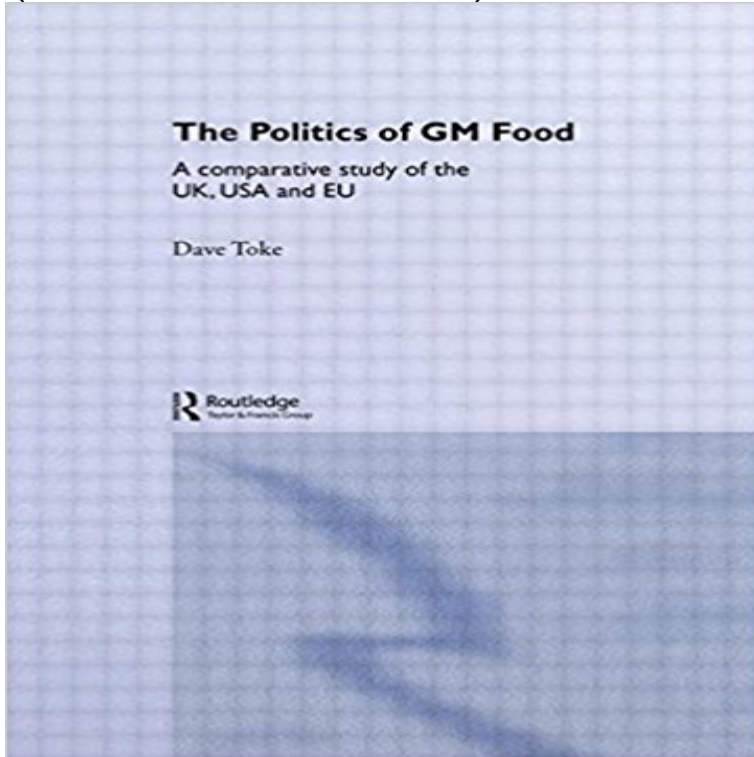


# The Politics of GM Food: A Comparative Study of the UK, USA and EU (Environmental Politics)
