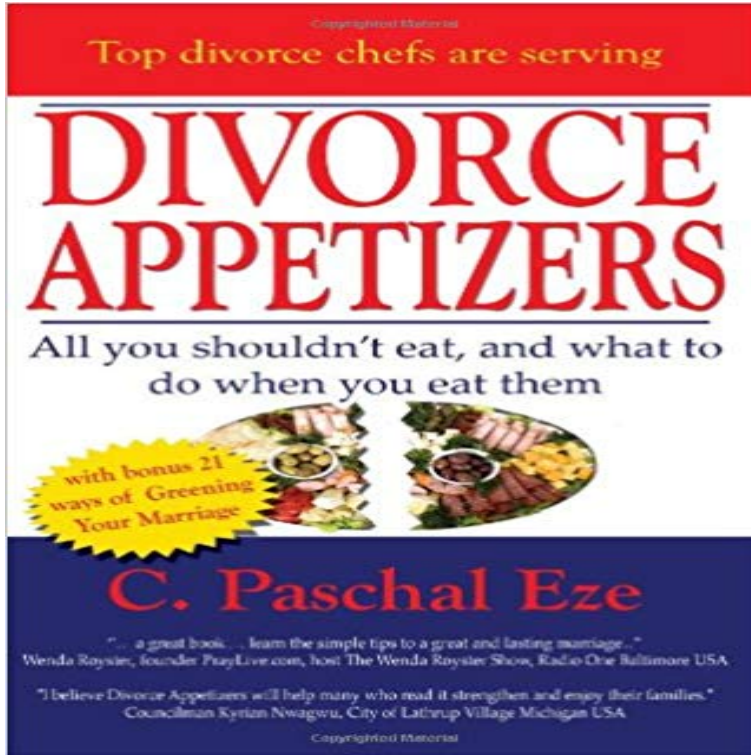


Divorce Appetizers: All you shouldn't eat and what to do when you eat them
