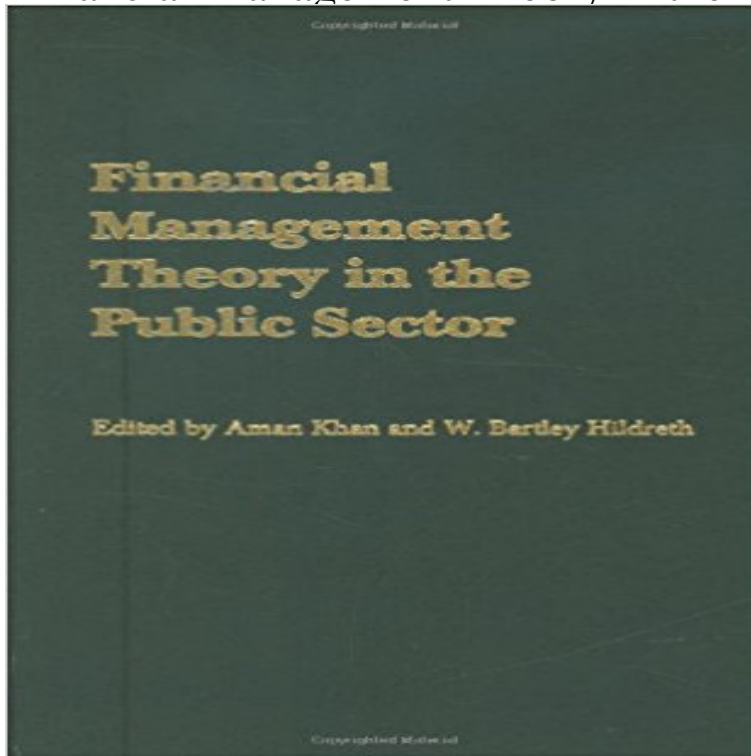


# Financial Management Theory in the Public Sector
