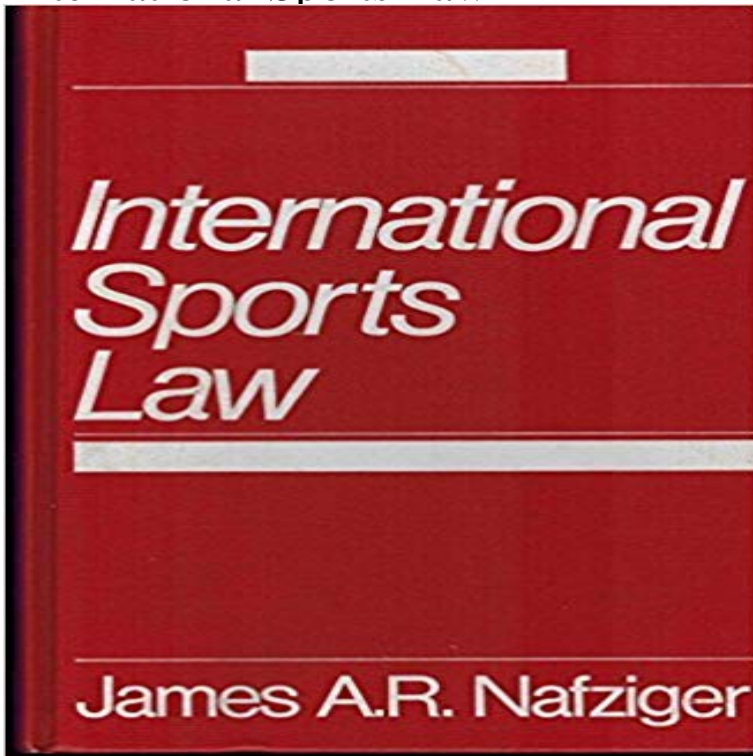


International Sports Law
