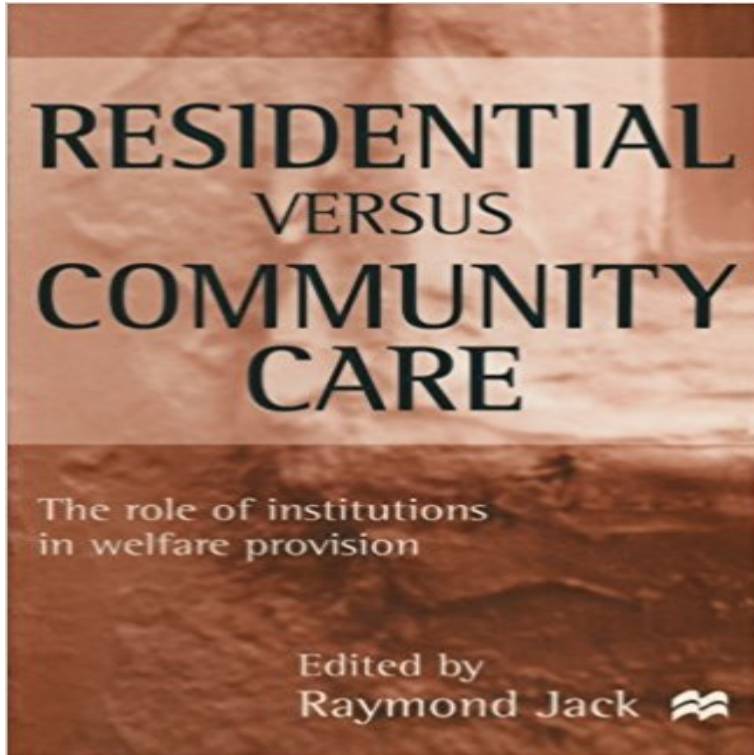


# Residential versus Community Care: The Role of Institutions in Welfare Provision
