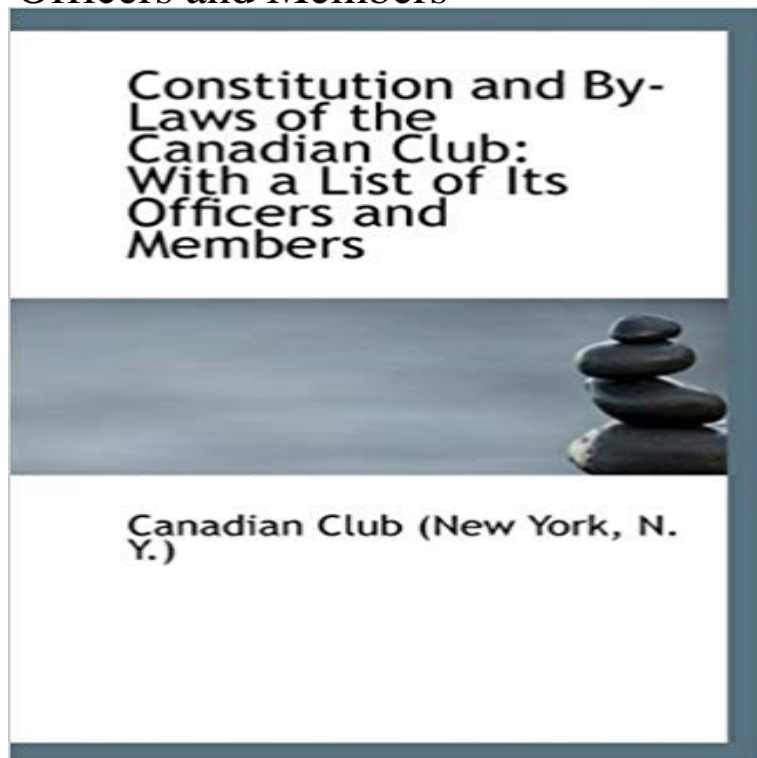


Constitution and By-Laws of the Canadian Club: With a List of Its Officers and Members
