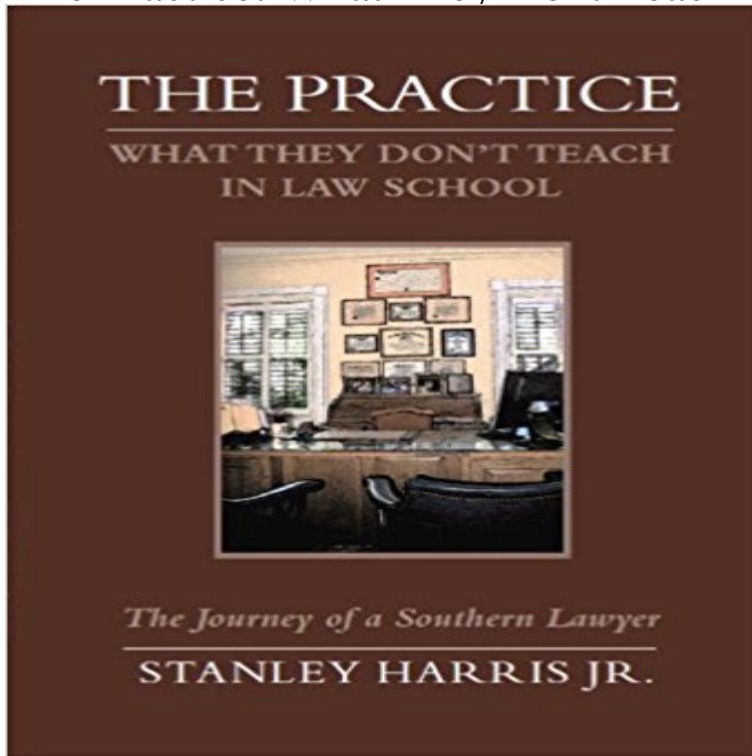


## The Practice: What They Dont Teach in Law School

Grahams story illustrates the importance of conceptual and imaginative thinking beyond the book learning of law school, whose curricula offered no guidance for managing relationships with colleagues and staff, dealing with practice economics, or attracting clients. The largest void entailed how to achieve a sense of accomplishment and satisfaction beyond the monetary rewards of a professional practice. Its a void that Graham fills admirably through trial and error (pun intended), offering this neglected edification to others pursuing a career in law (or, really, any profession).
